Let us admit that medications and drug replacements hold a special hazard for all addicts, not merely those with a history of abuse of these drugs. To the addict, medication or drug replacement represents a means of control, like any other tool of control it's use can become compulsive. Keeping in mind that we are not doctors, modern medicine often mistreats addiction with drugs. Drugs, whether self-prescribed or prescribed by a doctor, are a major part of our problem. How can drugs possibly be the solution?

WE ARE NOT DOCTORS

If we are not doctors then what are we? We are a fellowship of addicts seeking recovery from addiction. When we talk about addiction we are talking about being addicted to drugs. Our recovery program is one of total abstinence from all drugs. "Total Abstinence" is not a medical opinion but a practice of our principles. It is not an outside issue but one that is essential to our recovery. We follow a spiritual, not religious program that provides recovery through the 12 steps and 12 traditions of NA.

TOTAL ABSTINENCE

The cornerstone of the Narcotics Anonymous program is total abstinence from all mind and mood altering chemicals. Total abstinence is the first thing we hear when we arrive in Narcotics Anonymous. Total abstinence is the beginning, middle and end of our recovery. Our clean time, and our recovery from the disease of addiction begins with that first step. This pamphlet will address some of the spiritual principles we have used in our program to reach total abstinence from all mind and mood altering chemicals. We understand that there are cases where addicts are hospitalized and given narcotics for things such as major medical emergencies or major accidents. Our Basic Text already gives us the answers to these situations such as "Using local anesthesia, avoiding our drug of choice, stopping drug use while still in the hospital, and spending extra days in the hospital in case withdrawal occurs are some options". This pamphlet is not focused on these issues; this pamphlet is focused on drugs used by some doctors to treat the disease of addiction. So to the newcomer who has been put on any of these type of medications, please keep coming back. Although as addicts we are not responsible for having this disease of addiction, through NA we are given a choice to recover. Once we make this choice we are responsible for our recovery.

SURRENDER

The process of surrender is a result of living in utter desperation and pain. It is the result of working double overtime to find a solution that does not require giving up drugs completely. It is difficult to accept that drugs are the problem when we have not been able to find peace and serenity by any other means. When we make the decision to surrender, we get relief from the pain of making our own decisions. Surrender is positive for us because we find hope. Once we have surrendered, we open opportunities for other addicts to help us with our problems. We have seen many addicts surrender to this program and detox in the rooms of NA and live productive lives in society. We have also seen many addicts go to other places and detox and come back to NA and celebrate total abstinence in the rooms of NA. We know any addict can get and stay clean but they must surrender to the program of Narcotics Anonymous for that to happen. Surrender is just the first step to this process, there are many other key spiritual principles you will need along the way such as...

WILLINGNESS

We surrender to a program of total abstinence when we absolutely can not continue using and there is simply no fight left in us. Now we must become willing to follow some simple suggestions that we hear in meetings. We may not believe that these suggestions are going to help us but we do them anyway because we don't know what else to do. We may think that we don't need a sponsor but we get one anyway because we are afraid not to. We need to become willing to do anything to stay clean.

Willingness is a spiritual principle because it allows us to get a grip on the fact that before change can occur; we have to give our permission. We have to stop holding back inside. We have to relax our personal will with all its preconceptions and preferences so we can look at alternatives. When we want to select something new in our lives, the choice is up to us. Without our willingness, we never get to make the choice and remain tied up in many of our past limitations, illusions and habits.

'Willingness to try is the beginning of doing our part. However grand or humble that might be, it is a state of readiness replacing depression and anxiety.'

Once we become willing to put down the preconceived notion that total abstinence is impossible and surrender to the fact that we are just like everyone else in NA we can then move on to...

COMMITMENT

Commitment is one of the spiritual principles that most people don't connect to the first step. In past editions of the Basic Text it's written "Now the question is: "If we are powerless, how can Narcotics Anonymous help?" We begin by asking for help, and this is accomplished by working and living the twelve steps" where the spiritual principles we have discussed in this pamphlet come from. They are the backbone to a life of complete abstinence; without them we will die. Once we surrender and become willing to do what ever is necessary to become abstinent we need to stay committed to the process in order to not go back to the way of life we once knew. We need to make a commitment to a home group and stay clean no matter what. A commitment to a sponsor is also very important to this new way of life for we can not do this alone!!!

OUR SOLUTION

Our first step says "We admitted that we were powerless over our addiction that our lives had become unmanageable". If we still believe that limited drug use is possible then we have not taken step one, we have not surrendered, and we will use again. Step one is more than an admission of powerlessness, it must be followed by a change of actions. We must stay away from people that are using even if it means we must avoid family members, friends and co-workers. We might have to break free completely of everything and everyone we know. There is no substitute for surrender. This may be very uncomfortable but we do it anyway because we know in our heart of hearts that is the only way. Based on a life of desperation and a glimmer of hope we make a decision to turn our will and our lives over to the care of God, as we understand him. To sum up step three in a nutshell it is simply a decision to take the rest of the steps and to understand that they are the solution to maintaining total abstinence. Faith comes after this way of life becomes a reality. This way of life comes to some very fast and to others very slow but it doesn't come at all if we are still clinging to the idea that we can have it while still using. Remember these 4 things.

- 1) The cornerstone of the NA programis total abstinence.
- 2) There is no substitute forsurrender.
- 3) Recovery is a complete change of everything we think and do.
- 4) Without commitment to this fellowship of Narcotics Anonymous we will go back to the life we once knew.

A VIEW OF NARCOTICS ANONYMOUS GROUP CONSCIENCE Motion 2020 A

A Narcotics Anonymous Group is any meeting of two or more recovering addicts who meet regularly at a specific time and place for the purpose of recovery from the disease of addiction. All NA Groups are bound by the principles of the Twelve Steps and Twelve Traditions of NA. Each Group has but one primary purpose—to carry our message of recovery to the addict who still suffers. It is the most powerful vehicle for carrying that message.

The definition of conscience is a personal awareness of right and wrong that one uses to guide their actions to do right.

Our Second Tradition states, "For our Group purpose there is but one ultimate authority-a loving God as He may express Himself in our Group conscience, our leaders are but trusted servants, they do not govern."

Every Group should have a conscience. A Group without a conscience is an unconscious Group. A Group conscience is where we all come together and invite a loving Higher Power to guide us as stated in our Second Tradition. True Group conscience is a collective Eleventh Step applied to a single issue. It is the utilization of spiritual principles by members of a Group to preserve the common welfare and fulfill the primary purpose of the Group. It is developed by first inviting a loving God to express Himself and then listening to what He delivers through the voice of each and every member. All members should be encouraged to achieve an understanding of the first three Steps. Group conscience in NA is the responsibility of the NA Group and its members. When we surrender and seek out a loving Higher Power's will in our Groups we can obtain a true Group conscience. A Group conscience develops as a result of the process; indeed it is not the process itself.

When the NA Traditions were transcribed from AA, Group conscience was only a theory. Our predecessors said that they believed in something that did not exist. It is no longer a theory; Group conscience is now a reality.

"Group conscience is a collective understanding of, awareness of, and surrender to the principles within the Group; it is the basis of our decision making process." –An Addict.

Groups are autonomous and can function as they choose. However, it is important for a Group to strive for unanimity. In other words, make every effort to be 100% in agreement. The unanimous based process works well within an NA Group. The purpose of unanimity is so that everyone should be on the same page when guiding the Group. That way we have

a single voice and not multiple voices going on at the same time. The benefit of unanimity is unity. All input should be considered equally from every member. Care should be taken to insure that everyone feels safe speaking their conscience. There are no big I's and little you's.

WHAT IS NOT NA GROUP CONSCIENCE?

Conscience is not a popularity contest. Too often we have seen a strong personality sway the Groups' decisions. In Group conscience, what is best for the Group and its members, including those members yet to come, is usually best for the individual. It holds more importance than the personalities involved and is not about control or forcing self-will upon the Group.

Group conscience is not what happens in committee. Groups take instruction only from a loving God as expressed in Group conscience. Therefore, on issues that affect NA, the membership must be consulted directly so that the will of a loving God can be channeled through that process. Then the Groups are able to direct the service structure as to how to serve. Motions should originate only from an NA Group conscience. There is no "conscience" beyond the Group. Every other level of service merely compiles the conscience of NA Groups.

Group conscience is not a matter of simple vote. Instead it is a collective expression of every member's input. The business of the Group, defined by us as "How we spend the material component of the Seventh Tradition", is and always will be distinct from the spiritual business of the Group. The spiritual conscience of the Group influences how the money is spent. Ideally, the business of the Group will follow the conscience of the Group.

Robert's Rules of Order are not Group conscience. They were created to run government; therefore they are a form of governing which conflicts with the Second Tradition. Robert's Rules leaves the minority feeling marginalized. Its goal is to structure the debate and passage of proposals that win approval through majority vote. This process does not emphasize the goal of full agreement. Robert's Rules should not be used in a Groups conscience.

NA GROUP CONSCIENCE MEETING

As a Group we believe in distinguishing the conscience of the Group from everything else. Because of this distinction, we have our Group conscience Meeting on a separate day or time. In fact, in some parts of the world, it is common for a Group to have a separate Group conscience meeting. We dedicate our Group conscience meeting to God and use it as a vehicle to discover His will for our Group. Carrying the message is

so important that many Groups take inventory regularly to help insure that our primary purpose is still in focus. We want to assure ourselves through the inventory process that God's will is running the meetings. The process of taking our Group's inventory is the best effort we can make in allowing a loving God to influence the Group. This allows the Group to present an atmosphere of recovery which makes it easier for God's voice to be heard.

The format we use is simple and allows for free, orderly discussion between Group members. It stresses for our members to express their feelings on how we have been carrying the NA message. It also allows us to add or detract from our Group format to adjust for changing times, as well as providing a place where members may discuss matters affecting NA as a whole. In essence, our Group conscience meeting is ideally a purely spiritual event where we can feel God's presence in the room. Each Home group member seeks their own conscience through conscious contact with their Higher Power and brings it to the Group.

Here is a typical meeting format.

- 1. Moment of silence/opening prayer
- 2. The complete 2nd Tradition is read from the book Narcotics Anonymous Basic Text.
- 3.Group Inventory The Twelve Traditions may be used as an outline for a Group inventory. Some Groups use a specific set of inventory questions, such as, "How are we doing carrying the message to the addict that still suffers and reaching out to the newcomer? Are we abiding by the Traditions? Are there addicts our Group isn't reaching? How can we make our meetings more accessible? What can we do to make new members feel more at home? Has the atmosphere of recovery diminished? Would a change in our meeting format strengthen that atmosphere?"
- 4. Minutes from the previous Group conscience meeting are read.
- 5. Group inventory of commitments and their related committees is taken. "How are trusted servants doing?"
- 6.Old business Unfinished issues or any concerns or ideas that were brought up during the previous Group conscience meeting are addressed. We may or may not decide to act on these items.
- 7.New business. Everyone's input is needed. Group conscience is impossible without every member participating. This is where we might discuss other concerns like format changes. Unless everyone is on

the same page and in agreement we do not change anything on the spot. We table it until the next time we meet while we pray, meditate and talk to our sponsors about it. At that time, the concerns become old business. This is what we know as a true Group conscience. There is no need for a sense of urgency or time sensitivity. If it's a good idea today, it will be a good idea tomorrow. After all of the Group concerns are taken care of, other service boards or committee's concerns may be addressed.

Move domain name www.anonymifoundation.org + webpage and domain name www.nahelp.org to a new Hosting Company and built it with WordPress.

Intent proposal:

- More functionalities in building the webpage
- Cheaper hosting
- Improving accountability
- More secure

Current situation:

Hosting company: GoDaddy

- We have ownership over 2 domain names (\$45,38 every year for the 2 domain names to renew ownership)
- 2. Website builder (\$15,75 every month)
- All on the name of a member (the account)
- 4. Yearly costs: around \$234,38

At this moment we pay for the website builder every month. July 2020 has been payed for.

Proposal extra information:

- 1. Hosting company: Bluehost
- 2. Move 2 domain names. This will cost us \$17,99 to move them and own them the first year. After the first year it will cost \$35,98 every year to own the domain names.

3. No more website builder.

But use WORDPRESS as the webpage builder (An example will be shown at the FSC 2020) and start paying for Hosting only. Cost: \$2,95 a month for the first 36 months (\$106,2 for 3 years) and after that it will be \$7,99 a month for 36 months (\$287,64 for 3 years)

Why use Wordpress: easier to use and the program Wordpress is free. To host this is also cheaper. Next to that there will be more freedom, functionalities and options in building the webpage. You only pay for extra's plugins or theme's if needed. It also gives us the possibility to allow someone acces to the backend of the webpage to make changes without getting into the hosting account with acces to all the information (finances. ownership of products, etc)

- 4. Yearly costs upcoming 3 years:
- Year 1: \$124,19 (domain name + hosting 3 years)
- Year 2: \$35,98 (domain names)
- Year 3: \$35,98 (domain names)
- Year 4: \$323,62 (domain names

- + hosting 3 years
- Year 5: \$35,98 (domain names)
- Year 6: \$35,98 (domain names)

Average yearly amount: \$98,62


What is needed to make this happen?

Steps:

- Build webpage offline (as good as done already)
- 2. Buy hosting for the first 3 years.
- 3. Move 1 domain name: www. nahelp.org

- 4. Import the webpage on that Wordpress installation. (anonymifoundation.org will stay online, the current webpage is build on this name and the nahelp.org just links forward to it).
- 5. Move the second domain name: anonymifoundation.org

This way we can rebuilt the webpage without major changes in the way it looks, put the new one online before the old one is taken off, and keep ownership of our domain names.


our principles in front of my selfish desires.

God take my will and life guide me in my recovery and show me how to live. Lead me to live a life in which harmony of the mind, body, and spirit are aligned to bear witness to the power of NA and your gifts. When I first started learning some things about the History of NA, Traditions, and Service, I wanted to let everyone hear what I know and what I know is more than what you know.

I sought out the "best Home Group" and I wanted to point at everyone for what they were doing wrong.


I wanted to learn more and more to use the knowledge as a weapon.

I've seen some people come and go and they act just like I did.

Many people have told me, "You have changed."

Several addicts became my eyes and ears, they called me out when I was out of control, they told me to surrender, get off social media, stop trying to control things, allow others to be where they're at, and focus on your own recovery.

Eventually I surrendered and took a whole year off of social media. I stopped worrying about what NAW\$ was going to do next, I stopped trying to tell everyone what Total Abstinence really means, I stopped telling everyone that verifying and signing attendance documents was against our Traditions, I stopped trying to tell everyone that professionals write all the literature for NAW\$, and I stopped engaging in controversy.



have sat down with many addicts and tried to explain to them that what I did was wrong and what they're doing isn't good for the greater good of NA. It hurts our unity and causes internal conflicts and controversy. Many times, I'm met with excuses, denial, ego, self-centeredness, and then I'm met with the very thing I needed to do to begin with. Surrender and let the addicts be where they're at. Sometimes we can be each other's eves and ears and other times the addict is so self-absorbed and in denial that we cannot help them.

Eventually they find themselves alone and when in those times they may become open minded to hear what others have to say.

Surrender, Pray, and Let others be where they're at is what I keep saying to myself.

Just like a using addict that's in

denial, there's nothing we can do or say, they may become open minded or they may die.

2,5 years ago, me and 4 other members were having a conversation trough Skype. We liked it a lot and decided to do it weekly, thus the Saturday skype meeting was born. This was before COVID-19, and before there was a real need to it. It was an easy way to connect with people

I committed myself to be there every Sunday without excuses, and it did not take long before I was the only one left to keep it going.

I was planning to stop doing it,

but it was at that time that my friend Roberto was to sick to attend physical meetings, and so he joined the Saturday meeting.

his joyful way of sharing recovery was attractive for addicts to join and before I knew it the group grew into weekly attendance in between 15 and 20 people.

We started another skype meeting on the Sunday. We had the idea of starting one in the week as well so that everyone who could not go to a physical meeting due to illness could always join a meeting.

in these meetings I learned that it can be hard sometimes to feel the feelings of empathy. It is not the same when someone shares honestly through a screen as when you are in the same room, and you

can feel a divine presence. This does not mean it is impossible. I have been on many online meetings where I felt that indescribable feeling. It is just that online it seems to be easier for our disease to take a hold of me. I have had meetings where I was fully obsessed with how I looked in the camera. Meetings where there is no meeting after the meeting. I cannot explain it very well but those moments before and after the meeting have been the moments that saved my *ss.

I do believe that online meetings are a great tool, but if there is a chance for you to go to a physical one, you should take it with both hands.

This is/Was Amazing to Me

This is/was amazing to me. The idea was to get donations of \$750,000 during this 4-day telethon and they got 'they say' \$52,000. How is having a Telethon requesting people to donate to a nonprofit Corporation in any way a spiritual endeavor??

"Fundraising activity interferes with our faith that a God of our understanding will direct and provide for our fellowship if we follow traditions. Practicing tradition is our path to a higher power and true unity.

Fundraising activities divert time, resources, intention and focus of individuals and groups from our primary purpose as stated in Tradition Five. Extraordinary time and

energy are put into making events "successful" rather than purposeful.

When fundraising generates monies, controversy results "money, concernina property or prestige". The traditions are unequivocal about the danger to unity of these subjects. Prudent reserves may become inflated and committee's dependent upon fundraising events are pressured to raise more funds for bigger and better events. This further leads us away from the spiritual focus of our fellowship and our primary purpose as stated in Tradition Five.

Fundraising diminishes individual member's and group's abilities to effect change or voice discontent with any committee by the practice of withholding funds from the "basket" or donations from the group. Committees are often substantially financed by fundraising allowing them to ignore any diminished funding from the "basket". This principle created by our tradition's founders is inherent in the 7th Tradition and is a right granted to individual members.

Fundraising promotes governance rather than service, a clear contradiction expressed in the 2nd tradition. Committees may decide on activities supported by fundraising which may have no relation to the collective group conscience. Majority democratic votes are used by committees often to rationalize this behavior. Democratic votes while useful are not to be confused

with, nor are they the equivalent of, the spiritual concept of conscience of the fellowship. Governance of this sort is also justified by the notion that what we are doing is "good" or "necessary", are euphemisms for "the ends justify the means", hardly the most spiritual concept. Governance is organizational self-will and blocks the effect of "a loving God as he may express himself in or group conscience", central to the 2nd Tradition

Fundraising permits the receipt of outside contributions to the funding of our fellowship, precisely prohibited by our 7th Tradition. There is no way to establish membership at the time of sale of goods or services and some activities such as raffles, lotteries, auctions of donated merchandise and resale of outside event tickets skirt legalities and does associate our fellowship with outside enterprises."

Today was glad that there was another Gray Book meeting starting up less than an hour away from me. They want to keep low key and not let many know about them, so I won't post the information. It mainly is a bunch of newcomers that love the Gray Book but don't want to get chastised by the area or region. I went to support the Group as that is what we do. The normal chairperson ended up being at work, the person that was to chair the meeting ended up telling me 10 minutes before meeting by phone he wasn't coming because he had laundry to do, and my friend that has been around for a while that gave them the Grav Books was out fishing with his Daughter. So here I was no one showing up to a meeting that I had brought books from the GWG to support this meeting. A few minutes before the meeting started a couple addicts stopped and asked if there was a meeting. Of course, we were going to have a meeting. Then another addict showed up also. Later one regular attendee did show up to the meeting about a half hour later. One addict the couple minutes before we started talked honestly about not being sure if they were an addict, but they were checking out

NA to see if it was for her. The spirit we felt in the room was amazing. It was great to see how the book spoke to their hearts. It was possible to feel the spirit in the room as they kept reading and sharing and did not want to stop. The meeting went on for an hour and 45 minutes. The one addict that said they were not sure if they were an addict or not shared that they had made a choice and that they are an addict and wants the NA way. We left 30 books with them from the GWG and hope that they are used to inspire addicts every day. There is a little free library in the upstairs of the building, and I asked that they keep it stocked with books so that when they are taken more are available. It would have been easy to make excuses and get pissed off at the situation but instead just Surrendering and staying in the moment provided one of the most powerful experiences I have ever had in NA.

It was obviously an

inconvenience and there was pain involved with these changes but there were so many good consequences as a result. I started to meet the faces behind the names of the people that I had been communicating with on RFNA, I found someone that I wanted to sponsor me, I learned more about our history and I felt connected with other like-minded addicts that I had never felt before. A whole new world of NA opened up to me.



I could not control the circumstances that I found myself in or the state of the world. In the beginning I was filled with fear and was reacting to the chaos of the world and all I could do was pray and take action. I could not control that we could no longer have in person meetings and had to adapt to doing meetings online. No Longer on the Losing Side



We are Under No Surveillance at Any Time!

I remember back some years ago that I attended a meeting.



Upon walking up to the facility that it was located at I noticed there was a huge police badge on the building and the building read "Police Athletic League". When I walked into the front door, I saw an officer standing by a desk with a clip board. I hesitated as I approached him thinking I had to sign in while inside the building. At the time I had a warrant out for my arrest that I had not taken care of yet. I said, "Hello where is the NA meeting at?" He pointed me down the hallway.

When I went back to the room, I noticed there were big cameras in every corner, and the door stayed open in the room. I kept my hood up, grabbed some coffee, and paced myself around the room for a few moments hugging other addicts. I thought to myself today is the day they're finally going to get me

I was paranoid and did not share because I felt like they were listening to everything I was saying. Eventually after the first hour of the

two-hour meeting I went outside because I could not take the paranoia anymore. I saw addicts walking down the road to go score and I thought to myself, this does not seem very attractive at all. Why would they feel comfortable coming in here right now?

The Group asked me to share the next week and I had to decline, I told them I didn't feel comfortable being under surveillance.

Overtime I've seen many people be mandated to Narcotics Anonymous. I've seen addicts that were on probation that had to get a verification paper signed get honest in meetings about using, and how they somehow didn't fail drug tests; but they wanted help. I have seen those addicts get locked up because of their disease. Many addicts blame Narcotics Anonymous after they get locked up while they are on paper. Narcotics Anonymous did not give them a chance to recover if Narcotics Anonymous allows a government agency to put addicts under surveillance and mandate them to our rooms. Many times, we hear "If it just helps one then we will sign them." Well... It does not help them all so it must not be practical or spiritual. It doesn't seem like God's will to force someone to get clean.

Eventually after that meeting where I felt paranoid about getting arrested, I have dealt with my consequences. I was put on probation and have been on probation for about two years now.

I was fortunate enough to say that when they finally did get a hold of me, I had already been clean for a few years. They asked me what I did for my recovery and I told them I am just trying to do the next right thing. I didn't tell them anything more than they needed to know, and I have been probably one of few if not the only one that's on probation for drug possession in this county that is not on paper. I always told myself if they ever did ask me I would know what to say and how to show them it is wrong for requesting that I have an attendance paper verified at any 12 Step Meeting. Recently I had the chance to explain to another individual on how to avoid that, and it worked. This individual is not an addict and even if they were, if they do not want to come to meetings. I will not tell them they need to.

Furthermore, I believe what needs to be addressed is the bottom line.

Verifying attendance papers is a violation of our Twelve Traditions. Whether the Group is doing it before, during, or after the meeting it violates our Traditions. If another addict does it for the Group that isn't a part of the Group, the Group would then still be violating Traditions. The Group is responsible to the addict, so the Group should be doing real Public Information with the local government agencies not allowing these agencies tell us what we need to do.

Spiritual principles should never

be in-conflict with one another, so we follow God's will and have open mindedness. If we feel our attendance is lacking, we do Public Information in our towns or cities. We should never put our Group at risk with an outside issue in order to fill more seats, we have too much at stake.
